
How to Use this Guide

- **2. Provide a Floor Plan** (site plan) showing dimensions of your project or addition and its relationship to existing buildings or structures on the property and the distance to existing property lines.

3. Fill out a building permit application.

The majority of permit applications are processed with little delay. The submitted documents will help determine if the project is in compliance with building safety codes, zoning ordinances and other applicable laws.

This handout was developed as a basic plan submittal under the 2015 Uniform Codes. It is not intended to cover all circumstances. Check with your City of Grant Building Inspector for additional requirements.








